Minutes of the Board of Education of the Oelrichs School District 23-3 Annual Board Meeting July 21, 2025

Call to Order

The Board of Education of the Oelrichs School District 23-3 met in regular session on July 21, 2025, in the High School. The meeting was called to order by John Cope, Board President, at 5:00 pm.

Pledge of Allegiance

MOTION by Osmotherly, second Tlustos, to approve June 16, 2025, meeting minutes. Motion carried. MOTION by Tlustos, second Merdanian, to approve the agenda. Motion carried.

*All actions recorded in these minutes were by unanimous vote unless otherwise noted.

Public Participation – no participation.

School Board

Oath of office was administered to Katie Merdanian by Superintendent Stone.

Nominations were opened for President of the Board of Education. Tlustos nominated Cope for Board President, Merdanian seconded. Cope accepted the nomination. Hearing no other nominations, Cope was elected President. John Cope was sworn in as President by Dr. Stone. Nominations were opened for Vice President of the Board of Education. Osmotherly nominated Osmotherly as Vice President, Merdanian seconded. Cope nominated Tlustos as Vice President, Merdanian seconded. By paper vote, Tlustos was elected Vice-President. Lance Tlustos was sworn in as Vice-President by Dr. Stone.

Old Business

High School Construction: Dr. Stone informed the board that the shed has been set up. Merdanian recognized the great job and team effort of the custodial staff to complete that project. Stone gave the maintenance scheduling for both gym floors to be completed before school starts.

Board Reports: Merdanian requested that the donated TV be installed as soon as possible. She also provided an update about BHSSC.

Administration Reports: Dr. Stone informed the board that the Federal Grants Application opened in the middle of June and was due by June 30. This was a short time frame to complete but was accomplished. The tribal consultation signed off on the application in a timely manner. It has been reported that some of the Federal REAP funding has been frozen. The amount that will impact the district from this freeze is small. Stone informed the board that the Federal Program Fiscal Monitoring for FY24 has been closed. They accepted the corrective action plan submitted on July 17. Stone also informed the board that the elementary school still has an opening for a 4th/5th grade teacher.

FY26 Budget: Public Hearing @ 5:30

BE IT RESOLVED that the Oelrichs School District 23-3 after duly considering the proposed budget and after conducting a Public Hearing as per SDCL 13-11-2 does hereby approve and adopt its annual budget for the fiscal year July 1, 2025 through June 30, 2026. The adopted annual budget totals are as follows: General Fund \$ 3,168,048; Capital Outlay \$ 942,206; Special Education \$ 262,924; Impact Aid \$ 2,472,261; Food Service \$ 200,466. BE IT FURTHER RESOLVED, that the adopted annual budget levy requests are as follows pending modifications by the County Auditor to accommodate the sheltered property. General Fund: Ag maximum levy per \$1,000 of ag valuation; OO maximum levy per \$1,000 of non-ag owner occupied; Non-Ag Other maximum levy per \$1,000 of non-ag other property; Special Education: maximum levy per \$1,000 of total valuation; Capital Outlay: 216.005

28) MOTION by Osmotherly, second Tlustos to designate Schommer and the business manager Sword to the Board of Directors of the Black Hills Educational Benefits Plan. Motion carried.
