The goal is for students to return the week of January 19th. Terri Cornay applied and received a \$2,000 grant from GENYOUthFunds. The money can be used for the purchase of equipment and supplies needed for feeding students.

Personnel

Motion by Her Many Horses, second Tlustos, to accept the application of Lauren Stephens as music teacher for school year 2021-2022. Motion carried.

Executive Session

Motion by Tlustos, second Cope, to move to executive session to discuss employee qualifications and performance pursuant to *SDCL 1-25-2.1*. Motion carried. The board went into executive session at 5:06 PM and resumed open meeting status at 5:09 PM.

Motion by Her Many Horses, second Cope to increase Glen Elshire's custodial pay rate to \$15.68 per hour effective January 1, 2021. Motion carried.
