Minutes of the Board of Education of the Oelrichs School District 23-3 Regular Board Meeting November 20, 2023

Call to Order

The Board of Education of the Oelrichs School District 23-3 met in regular session on November 20, 2023, in the library. The meeting was called to order by Dave Osmotherly, Board President, at 5:00 pm.

Pledge of Allegiance Roll Call

MOTION by Merdanian, second Cope to approve October 17, 2023, meeting minutes. Motion carried. MOTION by Tlustos, second Merdanian, to approve the amended agenda, adding 8.1 Use of Facility. Motion carried.

Old Business

High School Construction Dr. Stone informed the board of the progress and plan for seeding the football field. Other areas that need grass seed include the alley area behind the high school and the playground behind the elementary school. Scull needs to be reminded to follow up on their commitment to seal the high school roof.

Bus Barn TSP scope of project is under review by Kyle. The board should consider forming a planning committee to make some preliminary decisions about what to do with existing structures; measurements; tentative layout; and heating.

Modulars There was discussion about the future of the two remaining modulars behind the elementary school. It was determined to surplus the furthest east modular under agenda item 6.0. The modular closest to the elementary school will need to be moved and possibly be a project for the CTE class.

Board Reports Merdanian attended Communities That Care. They continue to offer the open gym in Hot Springs. Erin from the 4-H club will be focusing on Fall River and will be able to commit to a regular schedule next semester.

Administration Reports Dr. Stone opened a new CD with higher interest rates compounded monthly. The existing CD's will roll into this plan as they mature. Dr Stone thanked the staff for their hard work to make the Halloween Carnival successful. The Veterans Day Program was nice, and Ms. Decker has been working on the Christmas Program. He also thanked the board for the Thanksgiving Feed. Over 252 meals were served, and Ms. Crofut did a great job getting the students involved. The school will be restarting the backpack program. Feeding South Dakota was contacted and will assist with providing food for students to take home for the weekends. The Copes will help deliver meals to Cubby's on Saturday.

Dr. Stone also recognized the custodial staff. The three new employees have strong skills and are working together to be a productive workforce.

The sports programs have started up. Dr. Stone feels the basketball coaching staff this year will be a nice addition to the athletic program.

Dr. Stone has been looking into options for purchasing a marquee. Next meeting, he should have more information. He has also been in communication with the City of Oelrichs to generate ideas on how to clean up various lots throughout the community.

November 20, 2023

The woodshop has started a project to build a shed from scratch. The teacher would like the board's support to generate public recognition and assist in options to sell the shed once it is completed. Principal Peterson informed the board that Tuesday will be a 'Drop Everything and Read' day. Midterm grades will be mailed out this week. Students with 10 or more days of absence will receive a truancy letter. Stone shared the tribe is interested in pursuing possible solutions to truancy issues. School wide MAP's testing will start in January.
