Principal Werdel, Reading Specialist Coleman, and Superintendent Stone went over AIMSWEB and MAPS data for the school board. K-6 data indicates that all grades are on an upward trend in Reading, and the board was able to see comparative data on the MAPS results from Fall to Winter. MAP (Measure of Academic Progress) assessments provide a variety of data about the students. We have tested K-12 in ELA and Math. The students will be tested one more time in May 2016.
