## Teacher House - 960 Elm Street: No action.

**Superintendent House:** Discussion about the condition and cleanliness of the house. Motion by Cope, second Her Many Horses to pay \$20 an hour to Darla Peterson to remove all the garbage and clean the Superintendents House. Motion carried.

**High School Construction**: The board reviewed proposals from independent consultants to inspect the high school gym floor. Motion by Her Many Horses, second Tlustos to approve Master Flooring Inspectors & Consultants, Inc. to perform floor inspections services on the high school gym floor, not to exceed \$7,500. Motion carried.

**High School Open House:** Dr. Stone acknowledged and thanked Principal Peterson for the hard work preparing for the open house. The board also wanted to recognize the time and gardening talent of Katie Merdanian and Jennifer Her Many Horses preparing the meal. The event was a success. **Beef:** Megan Harkless (local beef producer) and Amy Pravecek from Hulett, shared information about the beef to school process. Hulett School has had the program in place for several years and has been operated with all donated funds. She said that local producers provide the beef and others donate to pay the processing fee. Megan Harkless has a child currently attending Oelrichs School and he would like to donate a steer. Megan will work with the school head cook to develop a plan for next school year.

**Board Reports:** Her Many Horses attended BHSSC meeting. They shared information about the TIE Conference and teachers have access to receive continued education. She also attended the Town of Oelrichs council meeting.
